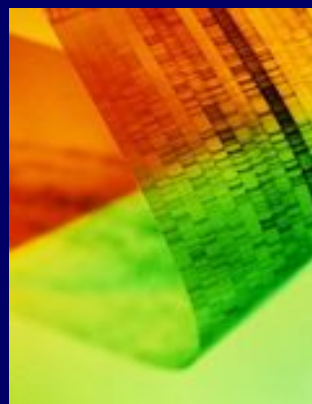

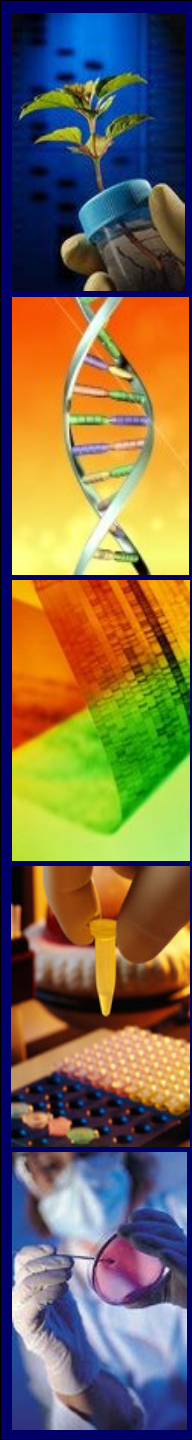

NSABB IWG Aims

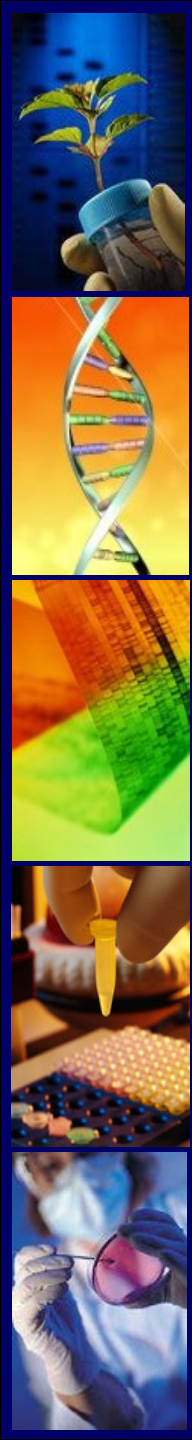
Developing and supporting the implementation of strategies to foster international engagement on issues related to dual use life sciences research

- **Maintain awareness of global activities**



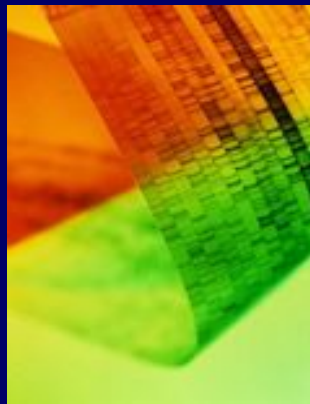
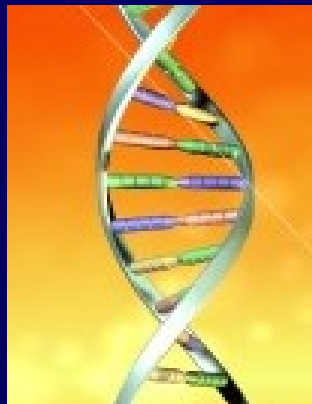
IWG Approaches

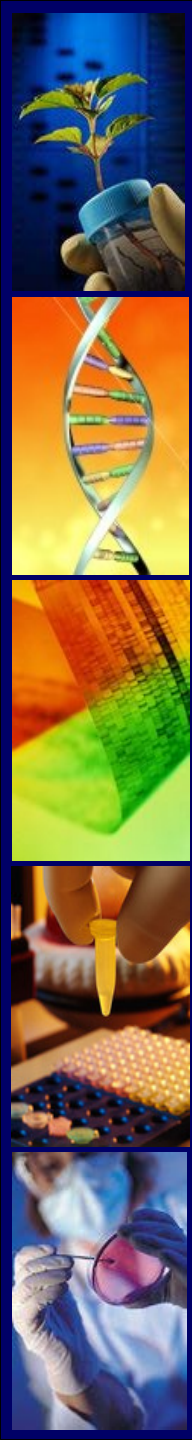

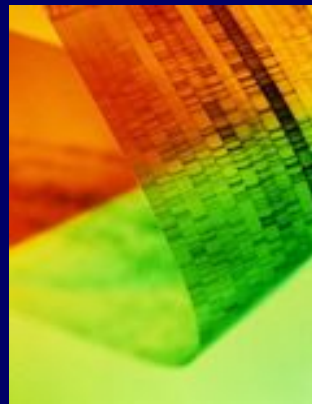
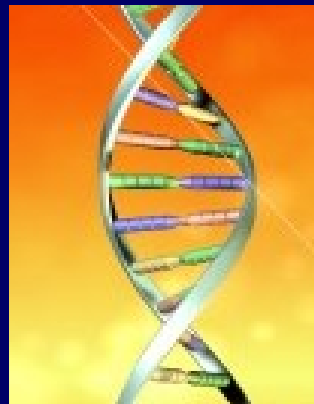


Geographic Distribution of International Engagement

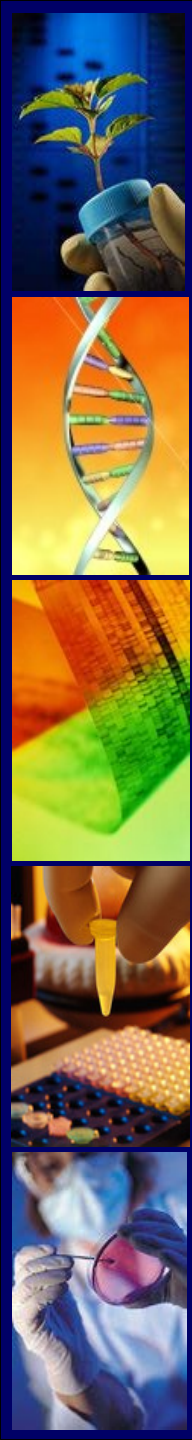

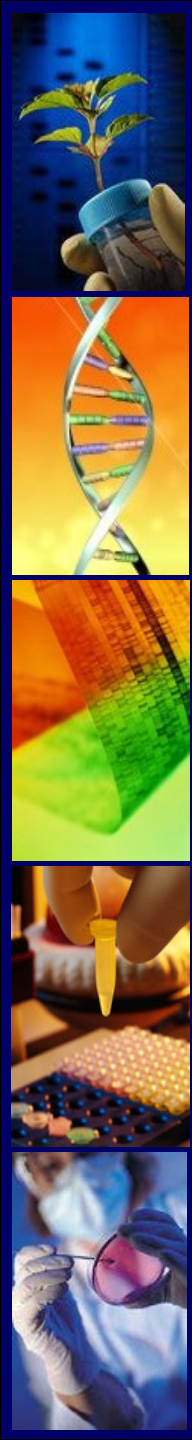
Trends in Science and Technology Workshop

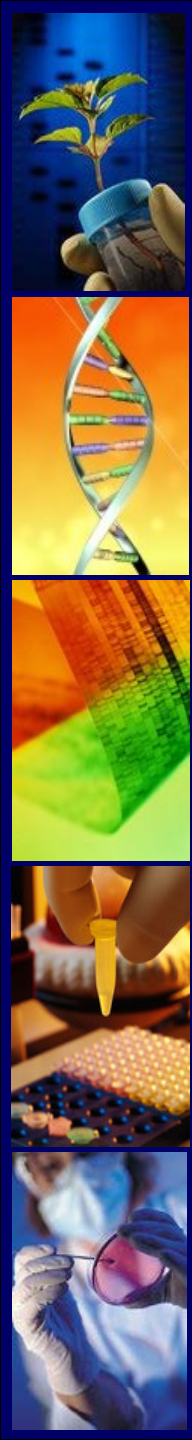
